Academic, Student Affairs & Enrollment Committee Meeting Minutes April 13, 2021

The meeting of the Academic, Student Affairs & Enrollment Committee of the Board of Trustees was held via Zoom. The meeting was called to order by Chair Tuman at 5:47 p.m.

1. Chair Tuman requested a motion to approve the minutes of January 12, 2021. Trustee Weiss moved the motion. Trustee Costanzo seconded the motion. Motion carried 3-0.

2. Strategic Plan – DRAFT Vision Statement

President Williams stated that the College is in the process of the Strategic Planning which is one of the major responsibilities of the Institutional Planning Committee (IPC). Dr. Lausch will give a brief overview on the process that the IPC used in creating the Vision Statement for the Boards review.

Dr. Lausch present the following outline:

- In January and February, the IPC reviewed the Vision and Mission Statements of other colleges to get a sense of the themes and aspirational nature of those statements to see how we could integrate them into our existing Vision Statement or create a new vision statement entirely for NCC given the new direction we want the College to go.
- In February and March, a Strengths, Weaknesses, Opportunities & Threats (SWOT) Analysis was completed and discussed which enabled us to frame up what the vision statement could look like.
- In March and early April, from those discussions a vision statement was drafted. Through this process key terms key terms and concepts that identified those strengths that we have at the institution, the direction the College could go to help leverage those strengths and opportunities while addressing the weaknesses and threats we face as a College. From there we framed up our vision statement.
- At the April 9th IPC meeting, the committee felt there were few additional key phrases or key concepts that could be added but before moving forward, the IPC wanted feedback from the Board on the draft statement:

"Nassau Community College transforms lives through equitable and inclusive educational opportunities."

Dr. Lausch asked the Board to provide their feedback on the statement in order to build upon or tighten it up to where it needs to be. This then becomes the foundation for our ongoing work to create our Mission Statement. Mission statement helps provide that guiding light or what we do with our Strategic Plan that would be in identifying our strategic priorities for the institution and from there the strategic plan is formed and then the individual supporting plans are created: Academic, Financial, Technology, Strategic Enrollment, and Facilities Plans.

3. Registrar Chester Barkan reported on Enrollment Updates

Dual and Concurrent Enrollment Update

Concurrent- Working with one district for a potential partnership for Fall 2021. The district has requested that all NCC classes be face to face on-campus for this program. They will provide the transportation to and from the College.

Dual Enrollment- Working with 8 districts on dual enrollment partnership for Fall 2021. Several academic chairs have been working with the College-wide Curriculum Committee to update their courses and look at the minimum qualifications to see if the HS teachers are qualified to teach the course for credit and going through the required paperwork process.
