2. Pending College Procurement Agreements for Board Approval—

A. The College currently does not have the resources, equipment or staff to perform this type of service and requires an outside contractor to perform this work. The Contractor will provide campus grounds care (IMP/wildlife/arborist management and irrigation repairs) in accordance with the Nassau County Integrated Pesticide Management Program. The anticipated annual expenditure of approximately \$900,000.00 is based on the previous agreement's expenditures.

B. The College currently does not have the resources, equipment or staff to perform HVAC maintenance and repair and requires an outside contractor to perform these services. This amendment is for Best Climate Control Corporation, the College's current HVAC maintenance and repair service contractor. Best Climate will furnish and install one (1) 1200 MBH heating and ventilation RTU in the Warehouse and one (1) 500 MBH in the Auto Garage. These new units will replace existing non-working units. It is recommended that in addition to the \$550,000 annual expenditure awarded to Best Climate Control Corporation there be a one-time increase of \$300,000.00 for this project.
