AGENDA ITEMS

- 1. <u>Minutes</u> of the Finance section of the Finance & Capital Committee meeting of May 8, 2018 were presented for approval. Trustee Green made a motion, seconded by Trustee Powers. The minutes were approved.
- 2. <u>Pending College Procurement Agreement</u>—There were no Pending College Procurement Agreements to be presented at the June 12, 2018 meeting.
- 3. <u>Comptroller's Report</u>—April 2018. Comptroller Izquierdo advised that the OTPS and PSC were reviewed for the month of April with no findings. The Accounts Receivable Report now includes figures for summer 2018 semester.
- 4. <u>Donation—Barnes & Noble:</u> Trustee Green made a motion, seconded by Trustee Powers. The donation of surplus supplies of paper, rulers, scissors, and muslin fabric from Barnes & Noble will be recommended to the full Board of Trustees for approval.

- 5. <u>Resolution—Minimum Wage Increase:</u> Trustee Green made a motion, seconded by Trustee Powers. All were in favor of presenting the resolution to the full Board of Trustees for approval.
- 6. <u>Discussion—Fiscal Year 2019 Budget Status</u>: VP Reznik gave an update of the budgetary process. On June 4, 2018, the FY 2019 Nassau Community College budget, previously approved by the Board of Trustees at the May 8, 2018 meeting, was presented to the Finance Committee of the Nassau County Legislature. The FY 2019 budget will be submitted to the Full Nassau County Legislature on Monday, June 18, 2018. Once approved at the County, the FY 2019 budget will be sent to SUNY for approval. VP Reznik advised that the FY 2019 budget will not be presented to SUNY until September; however, once the Nassau County Legislature approves the budget, it allows Nassau Community College to move forward with the process. Short discussion followed.

Trustee Powers introduced new Board members John Durso and Alex Vigueroa, Student Trustee for the 2018-2019 academic year.
