BE IT FURTHER RESOLVED THAT THE FOLLOWING ENTITIES SHALL HAVE THE RIGHT TO RECOMMEND ONE REPRESENTATIVE OF THEIR CHOOSING FOR APPOINTMENT AS A MEMBER OF THE COMMITTEE: ACADEMIC DEPARTMENT CHAIRS; ACADEMIC SENATE; ADJUNCT FACULTY ASSOCIATION OF NASSAU COMMUNITY COLLEGE; CIVIL SERVICE EMPLOYEES ASSOCIATION (CSEA COLLEGE EMPLOYEE); MANAGEMENT/CONFIDENTIAL

STAFF; NASSAU COMMUNITY COLLEGE ADMINISTRATORS ASSOCIATION; AND NASSAU COMMUNITY COLLEGE FEDERATION OF TEACHERS; AND

BE IT FURTHER RESOLVED THAT ONE ALUMNUS/A OF THE COLLEGE AND ONE MEMBER OF THE COLLEGE FOUNDATION BOARD, NEITHER OF WHICH SHALL BE AN EMPLOYEE OF THE COLLEGE, SHALL BE APPOINTED TO THE SEARCH COMMITTEE AS REPRESENTATIVES OF THE COMMUNITY, AND

BE IT FURTHER RESOLVED THAT TWO MEMBERS SHALL BE APPOINTED TO THE SEARCH COMMITTEE BY THE BOARD FROM NOMINATIONS RELAYED TO THE BOARD BY CAMPUS CONSTITUENCIES OR INDIVIDUALS WHO ADVOCATE THAT REPRESENTATION OF THEIR NOMINEES WOULD ENHANCE THE EFFECTIVENESS OF THE SEARCH, AND

BE IT FURTHER RESOLVED THAT THE ENTITIES ENUMERATED HEREIN, AND THOSE CONSTITUENCIES SUBMITTING NOMINATIONS, SHALL HAVE UNTIL 5:00 P.M. ON MAY 18, TO RECOMMEND THEIR SELECTION OR NOMINATION OF A REPRESENTATIVE TO THE SEARCH COMMITTEE AND FORWARD THEM TO THE SECRETARY OF THE BOARD, AND IF NO RECOMMENDED CANDIDATE NOR NOMINATION IS FORWARDED BY THE STATED TIME, THEN THE OPPORTUNITY TO BE REPRESENTED ON THE SEARCH COMMITTEE IS THEREAFTER FORECLOSED, AND

BE IT FURTHER RESOLVED THAT THE INDIVIDUALS COMPRISING THE SEARCH COMMITTEE SHALL BE ESTABLISHED BY BOARD RESOLUTION AT ITS REGULARLY SCHEDULED MEETING ON JUNE 12, 2018.

Chair Gardyn requested a motion to consider this item. Trustee Tuman made the motion; seconded by Trustee Weiss. Motion carried 7-0.

Dr. Keen reported on the following items:

- The Administration, the Calendar Committee and Academic Senate Executive Committee are working to arrange for make-up of instructional time lost during the Spring 2018 semester due to inclement weather, and this make-up time will be more effectively built into future calendars.
- Registration for Summer and Fall 2018 semesters has begun. We are formulating actions to reverse the decline of enrollment, continuing concerns about which were discussed in committee meetings this evening.
- NCC students were honored earlier today at a very impressive ceremony for their involvement in both campus activities and the classroom. Among those acknowledged were the ten winners of the SUNY Chancellor's Award for Student Excellence, who last week in Albany were also honored by Chancellor Johnson with their peers from all SUNY campuses. Trustee Thérèse Russell, one of the Chancellor's Award winners was also named the Northeast Regional Honors Council Student of the Year for 2-year colleges.
- The Speech, Debate and Acting Team has again been awarded high honors in its second national competition of the year. At the Community College National Tournament, in individual competition NCC students won three (3) Gold Medals and two (2) Runner-Up Silver Medals, and the team won the Bronze Medal. He commended Professor Trent Webb for his outstanding mentoring and coaching role over the years.

Speakers List

Frank Frisenda, NCCFT President, praised the broad spectrum of representation being sought for the Presidential Search Committee. He asked Dr. Keen how the process would work for the proposed appointment of two members from the College to represent specific organizations on the Presidential Search committee, and whether an explanatory email would be forthcoming to the campus.

Dr. Keen stated that on the subsequent day the Board would send an email to the College community which will describe the process in detail.

Prof. Frisenda reminded the Student Trustee that she has an obligation to represent the students. In anticipation of Board approval of the budget at its May meeting, he would like reconsideration of the Board's late decision absent public discussion last year to reduce tuition by \$30. He argued that the \$30 reduction per student each semester will be compounded every year, and that the presumed savings do not take into account the services lost currently and in years to come. These lost services are not frivolous; they are for student support and help increase retention.

Chair Gardyn proffered that the College is receiving more money from the State.

Prof Frisenda replied that he appreciates those increases, but is focusing on what is under the Board's control.

Chair Gardyn announced the next Capital and Finance BOT Committee meeting is scheduled for Tuesday, May 8, 2018 at 5:00 p.m. followed by the Full Board meeting. The Board will open the public session between 6:15 and 6:30 p.m. and resume the public session approximately 7:30 p.m.

Chair Gardyn requested a motion to adjourn the meeting. Trustee Weiss moved the motion; seconded by Trustee Tuman. Motion carried 7-0.
